Darlene lived in a housing co-op for 11 years. During that time, she served 6 years on her co-op's Board, and 4 years on the NACHA/Casa Board of Directors. Darlene loves sharing her knowledge and experience to anyone who will listen.

**THOMAS GRENIER** is as an affordable housing specialist with the Canada Mortgage and Housing Corporation (CMHC) who works with non-profits, governments, and corporations across Alberta to create financial avenues for the creation of affordable and sustainable housing. Thomas has a strong understanding of the logistical hurdles that exist around urban planning, housing access, NIMBYism, and ballooning costs of land.

**BLAIR HAMILTON** Blair Hamilton is CHF Canada's Manager Prairie Region. Blair provides direct member services to CHF Canada member co-ops in Manitoba and Saskatchewan. In Alberta, Blair is the first point of contact for CHF member co-ops seeking to access various services from the national federation.

**IRFAAN HASHAM**, Regional Energy Coach and one of the cofounding principles at Simply Sustainable Energy Solutions (SSES), has a great deal of experience in both the consulting and utility worlds. He is registered as a Certified Energy Manager (CEM) and Certified Measurement & Verification Professional (CMVP), and holds a Bachelor's degree in Electrical Engineering.

**HEATHER KEAM** is the Team Lead for the Cities Deepening Community practice area at Tamarack Institute. Heather has 18 years of experience generating action at a grassroots level. She loves guiding groups through community planning, implementation and sustaining local efforts.

SANTOSH KUMAR is the Director of Legislation at the International Cooperative Alliance (ICA) office in Brussels, Belgium. He joined the ICA Asia and Pacific (ICA-AP) in 2010 where he worked until March 2019. He served the ICA-AP as secretary of Committees on Youth Cooperation and on Cooperatives in Educational Institutions, as programme manager of the ICA-EU Partnership on Cooperatives in Development (Coops4Dev). He has contributed to the publication of the 4th Critical Study on cooperative laws and policies in the AP, and the 1st ICA-AP study on by laws of primary cooperatives in the AP. He was employed as Legislation Coordinator at the ICA Global Office from April 2019 until March 2021 whereupon he was appointed as Director to liaise better with ICA bodies such as ICA regions and sectors. He has undertaken specific certification courses in Cooperative Laws and Management, and Platform Cooperatives in 2020. Currently, he is undertaking a course in Public and Private international law from the Hague Academy of International Law.

**CONNIE LESLIE** has worked at Springhill Ranch Housing Cooperative (SRHC) in Calgary for just over 10 years. She has been trained as a Property Manager through the Institute of Housing Management through a scholarship awarded to her through CHF Canada. Connie strives to continue her education and stay-up-to date with an ever-changing environment.

**JUSTIN THOMAN** began his forensic accounting career in 2000 as an in-house forensic accountant with the Integrated Proceeds of Crime Section of the Royal Canadian Mounted Police. In 2002, he joined a major international accounting firm as a Senior Manager, becoming the practice leader in the forensic accounting and investigative services area in Edmonton. He founded Thoman Forensic Accounting shortly after resigning from this position in late 2007.

Justin's experience extends to many industries, government programs and non-profit organizations. He has also instructed at various courses in forensic accounting and fraud investigation.
